 - Social Psychology-I & II were shifted from Semester III & IV (PSY 314 & 414) to Semester I & II (PSY 114 & 214).
 - Paper codes Systems & Theories of Psychology I & II, which were earlier PSY 513 & PSY 613 in Semester V & VI were shifted to Semester III & IV as PSY 314 & PSY 414 respectively.
