The agenda items were taken up and after considerable deliberations, following decisions were taken:


1. The Minutes of the last meeting held on 20.01.2015 were considered and approved.

  - (i) B.A. (Pass Course) –Sems 1 and II (2016-17), Sems.III and IV(2017-18) Sems. V and VI (2018-19).
  - (ii) B.A. (Honours)-Sems. I and II-(2016-17), Sems. III and IV (2017-2018), Sems. V and VI (2018-2019).
  - (iii) M.A. – Sems. 1 and II (2016-17) and Sems. III and IV (2017-18).
  - (iv) Foundation Course Sems. I and II for B.A./ B.A.(Hons.)/ B.Com./B.Com. (Hons.)/B.Sc./B.Sc (Hons.) /B.Sc.(H.Sc.) / BBA/ B J M C (2016-2017).

The above mentioned courses were approved as proposed.



6. The Syllabus for M.Phil/Ph.D. Course work was put before the members for their perusal.


The meeting ended with a vote of thanks.
