

### SUMMARY OF THE BOS MEETING OF ENVIRONMENTAL SCIENCE **HELD ON 22.02.2019**

A new paper entitled Industrial and Occupational Health (ENV 423 B) has been introduced as elective paper in M.Sc. Semester IV and the nomenclature of the paper Remote sensing and GIS (ENV 423) has been changed to Remote sensing and GIS (ENV 423 A).
